Appointees shall report to the Director Colleges J&K, Jammu within a period of 21 days from the date of issuance of order and he/she shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

- 1. Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- 3. Health Certificate issued by the Competent Authority.
- 4. Permanent Resident Certificate.
- 5. All other relevant certificates.
- 6. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.

In case appointee fails to join within the stipulated period of 21 days, his/her appointment shall be cancelled without any further notice.

The appointment of above candidates shall governed by the "Jammu and Kashmir Special Recruitment Rules" as per SRO-202 of 2015 dated: 31-06-2015.

The appointment shall be subject to the following conditions:-

a) The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case adverse report about his/her character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the concerned Principal, his/her appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his/her appointment and also criminal proceeding shall be initiated against him/her.

b) The verification of qualification/reserved category certificate (wherever applicable)

from the concerned quarter/issuing received.

Salary of the appointee(s) shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

The seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board J&K.

Further, if on verification, at any stage, the certificates produced by the appointee found fake or forged, the appointment shall be treated as cancelled abi-initio.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending in any court of law.
