Whereas, JK Public Service Commission vide letter No. PSC/DR/AP Sanskrit/113-14 dated 26-12-2016 among others selected Smt. Sunita Devi D/o Sh. Jamit Raj R/o Glar P/o Pangdhour Tehsil and District Samba as Assistant Professor in Sanskrit and recommended her name in the selection list under Schedule cast category figuring at S. No.1; and

Whereas, order of appointment in favour of selected candidates were issued by the department vide Government Order No. 15-HE of 2017 dated 06-01-2017 with directions to report Nodal Principal, Jammu for attending induction programme; and

Whereas, Ms. Sunita Devi reported GGM Science, Jammu on 07-01-2017 and attended requisite training programme; and

Whereas, in mean time the department received orders of Hon'ble J&K High Court (Jammu) in SWP No. 16/2017 MP No. 1/2017, 01/2016 titled Deepu Pandita V/s State & Ors in respect of Ms. Sunita Devi with the following directions:

"subject to objections and till next date before the Bench, action pursuant to the recommendation of the Commission shall remain in abeyance qua respondent No. 3 only".

Whereas, the department issued orders posting in favour of selected candidates vide Govt. Order No. 100-HE of 2017 dated 14-02-2017. However, orders of posting in respect of Ms. Sunita Devi were kept in abeyance in light of Court directions; and

Whereas, the Hon'ble Court during examination of similar cases clubbed the instant case and dismissed such clubbed SWP No. 81/2017 MP No. 1/20-17, SWP No. 16/2017 Nos. 1/2017 and 2/2017, SWP No. 2424/2016 MP Nos. 1/2016, 2/2016, 1/2017, 2/2017, 5/2017 & 4/2017 SWP No. 1543/2016 MP Nos. 3/2017, 4/2017, 5/2017, 1/2016 & 2/2017, SWP No. 1522/2016 MO Nos. 2/2016 and 01/2016. The operative part of the judgement passed on 26-04-2018 is reproduced as under:

"these petitions are found to be without any merit and are accordingly, dismissed alongwith connected MP(s)".

Whereas, the Principal GGM science College, Jammu vide letter No. GGM/Sc/Coll/1321 dated 24-07-2018 communicated that Ms. Sunita Devi appointed as Assistant Professor Sanskrit vide Government Order No. 15-HE of 2017 dated 06-01-2017 and is continuing in the college without further posting orders.

Now, therefore, in pursuance of orders of Hon'ble High Court Ms. Sunita Devi, Assistant Professor, Sanskrit is posted in Government Degree College, Samba against the available post with the terms and condition as laid down in her appointment order issued vide Government Order No. 15-HE of 2017 dated 06-01-2017 has joined on 07-01-2017.
