Sanction is hereby accorded to the appointment of Mr. Nisar Ahmad Shiekh S/o Nazir Ahmad Shiekh R/o Lajurah P/o Pulwama District Pulwama (Open Merit) as Assistant Professor (Political Science) on regular temporary basis, in the pay scale of Rs.15600-39,100 with AGP of Rs.6000/- (Pre-revised, Academic Level 10 with pay structure of Rs. 57,700/-) in the Higher Education Department.

The appointment of the candidate shall be subject to the following conditions:

- a. The appointee will be on probation for a period of two years from the date of joining in the respective Colleges.
- b. The appointment of the candidate will be subject to verification of satisfactory character and antecedent by the CID.
- c. The salary shall not be drawn till satisfactory character and antecedent reports are received from the CID authorities. In case any adverse report is received, the appointment shall be deemed to have been cancelled without any notice.
- d. The appointee shall, at the time of joining, produce the following testimonials in original which will be verified by the Principal concerned before formally allowing him to join:
 - i. Permanent Resident Certificate.
 - ii. Date of Birth Certificate.
 - iii. Qualification Certificates i.e. NET/SET/Ph.D.
 - iv. Category certificate as may be applicable to the appointee.
 - v. A certificate from the Dy. Director Employment that the candidate has liquidated loan taken if any.

Consequent, upon the appointment of Mr. Nisar Ahmad Shiekh S/o Nazir Ahmad Shiekh R/o Lajurah P/o Pulwama District Pulwama (Open Merit) as Assistant Professor (Political Science), he is posted in Government Degree College, (Boys) Pulwama against an available post.

The appointee shall report to the Principal concerned within a period of 21 days from the date of issue of this order failing which his appointment shall be deemed to have been cancelled without any notice.

The Inter-se-seniority of the above candidates shall be issued later on as per their merit.

The appointment of the candidates shall be subject to outcome of writ petitions, if any pending, before any Court of law.
