Subject:- Cancellation of appointment of Assistant Professor (Political Science) in Higher Education Department.

Whereas, J&K Public Service Commission vide letter No. PSC/DR/asst.Prof./Political Science/13-14, dated 12-12-2017 recommended Mr. Javid Iqbal Wani S/o A.R. Wani R/o VPO Mahore Tehsil Mahore District. Reasi (under Open Merit Category) among others for appointment as Assistant Professor (Political Science) in Higher Education Department;

Whereas, J&K Higher Education Department vide Government Order No.04-HE of 2018 dated 01-01-2018 accepted recommendations of J&K Public Service Commission and appointed him as Assistant Professor (Political Science) on regular temporary basis, in pay scale of RS. 15600-39100 with AGP of Rs. 6000/- and with the direction to report to Principal, Govt. Degree College, Chatroo within a period of 21 days from date of issuance of appointment order failing which his appointment shall be deemed to be cancelled without any noticed;

Whereas, Nodal Principal, GGM, Science College Jammu vide letter No. GGM/Sc/coll/5679 dated 06-03-2018 has intimated that above Assistant Professor has not joined his service within prescribed time and as such the post is lying vacant;

Whereas, this Department served a notice vide HE-Coll/Apptt./Pol.Science/2017 dated 14-05-2018 to above said appointee with directions to join his place of posting within a period of 10 days from the date of receipt of Notice or its publication in local News paper uploading on official website of Higher Education Department, whichever happens earlier, failing which his appointment shall be cancelled without any further notice;
