Subject: - Initiation of regular departmental action against Sh. Satinder Singh,
Principal GGM Science College Jammu.

Whereas the General Administration Department vide OM NO: GAD(vig) 133-RDA/2017 dated:20/10/2017 forwarded a copy of letter No VO-PE-JMU-03/2015-15275-76 dated:- 12/09/2017 alongwith connected documents of Vigilance Organization for consideration of the recommendations of Vigilance Organization for initiating regular departmental action against Sh. Satinder Singh Principal, GGM Science College Jammu for engagement of local fund employees on need basis without the approval of Administrative Department and printing work of answer sheets/attendance registers and other stationery/printing work through private press without obtaining NOC from Government Press;

Whereas, the Department constituted a Departmental Inquiry Committee headed by Additional Secretary to Government Higher Education vide Order No:- 212- HE of 2017 dated: 19/12/2017 for holding enquiry into the allegations leveled against Sh. Satinder Singh Principal, GGM Science College Jammu;

Whereas, the enquiry committee after examining the allegations with reference to the records available in the GGM Science College furnished its observations/recommendations as under:-

"In view of the background of the case and supporting documents enclosed, the committee is of the view that the engagement of need based employees have been made purely for smooth functioning of the college as have been made by the Principals of other colleges of the state. These candidates shall have no right for their regularization.

With regard to printing of magazine/purchase of the stationery items from private firm, the action has been taken by the Principal after taking up the matter with Manager Government Press and in absence of their response purchased items from super bazaar and private firm after completing codal formalities i.e. floating tenders and offering lowest rates. The items purchased have been entered in concerned stock registers and issued properly.

Therefore, authorities may take a lenient view. However, all the Principals need to take prior /post facto approval for engaging need based employees for smooth functioning of their institutions keeping in view of the ban"

Whereas, the report furnished by the enquiry committee was examined in the Department and the recommendations, of the departmental committee are accepted by the competent Authority; and

Now, therefore, in view of the above, Dr. Satinder Singh, Principal, GGM Science College, Jammu is hereby exonerated of the charges leveled against him with warning to remain careful in future and obtain approvals as may be due and necessary.
