On the recommendations of the J&K Services Selection Board, Sanction is hereby accorded to the temporary appointment of candidates as per Annexure-A to this order, against the posts of Junior Assistant in the Higher Education Department in the Pay Level-4 (25500-81100) with immediate effect.

The appointees shall report to Director Colleges, J&K, Higher Education Department within a period of 21 days from the date of issuance of this order and such candidates who fail to join within the stipulated time, shall forego their right to appointment, and the same shall be deemed to have been cancelled *ab-initio* without any further Notice. The appointee shall be allowed to join only on production of following documents (in original) to be verified subsequently:

- i. Academic/Qualification Certificates.
- ii. Matriculation/Date of Birth Certificate.
- iii. Health Certificate from the concerned Chief Medical Officer of the District.
- iv. Domicile Certificate issued by the Competent Authority.
- v. That if the candidate has taken loan for self employment from DIC /Employment Department, to be ascertained from the District Industries Centre (DIC) and District Employment and Counseling Centre of the domicile District, he/she shall relinquish the proprietorship of unit/enterprise and also stakes, if any, in such self-employment unit/enterprise before joining the Government Service. He/she shall be required to repay the entire loan liability in suitable EMIs to be worked out by the DDO concerned from his/her salary. DDO concerned shall obtain an affidavit from the concerned appointee regarding both relinquishment of proprietorship and stakes, if any, in such a self-employment unit/enterprise and recovery to be made and also personally monitor its recovery.
- vi. Valid relevant Category Certificate, if any applicable.
- vii. Any other certificate required under rule.

The appointment of the candidates shall further be subject to the following

conditions:

a. The clearance received from the Criminal Investigation Department, J&K is provisional and it shall be mandatory for the appointee to fill in the

Verification Rolls (V-Rolls) as available through the online mode under the Electronic Employment Verification System (EVS). Any false information provided by the appointee or an adverse finding subsequent to the V-Roll submitted electronically shall result in cancellation of appointment ab-initio without any further notice.

- b. If, on verification of the qualification certificates/DOB and other documents from the concerned issuing authority are proved fake/forged, the claim of the appointee(s) for appointment as Junior Assistant(s) shall be deemed to have cancelled ab-initio and the legal action as warranted under rules shall be initiated against his/her.
- c. The salary of the appointees shall not be drawn and disbursed to them unless the satisfactory reports in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and Final Character & Antecedents Report is received from the concerned Authorities/Agency.
- d. The appointees shall be on probation for a period of two years.
- e. The appointment of the appointee(s) shall be governed by the "New Pension Scheme" as notified vide SRO-400 of 2009 dated 24.12.2009.
- f. The inter-se-seniority of the appointee(s) shall be determined as per the J&K Civil Services (Classification, Control and Appeal) Rules, 1956.
- g. The appointment of the above appointees shall be subject to outcome of writ petition(s), if any, pending before Competent Court of law.
- h. In case of any certificate lying found fake/ incorrect, the appointment of the candidate shall be taken to have been cancelled ab-initio.
