The above said District Nodal Principals (DNOs) shall perform the following functions in their respective District under PM- USHA with immediate effect:-

1. To Collect /Compile the requisite data of their respective Districts on the devised template to be furnished by the Mission Directorate RUSA J&K under component namely, New Model Colleges, Gender Inclusion & Equity Initiative etc.
2. To upload the said requisite Data of PM-USHA Portal after due approval of the same from the competent authority for onward submission to the Ministry.
3. To coordinate with their respective District Administration to provide adequate Govt. Land (if required) under any of the above components.
4. To get preparation of DPRs from concerned PW (R&B) Division and uploading the same on PM-USHA Portal, accordingly after the approval of competent authority.
5. To supervise & Monitor of implementation & execution of these projects at the district level.
6. To Monitor fund flow on the PM-USHA Portal & ensure its proper utilization on the component for which it would has been sanctioned & generation of necessary reports.
7. To prepare& furnish component wise proposal after utilization of 75% or above funds released along with utilization certificate to Mission Directorate RUSA (J&K) forensuing release of further instalment from Ministry of Education Gol.
8. Any other function pertains to PM –USHA.
