**Whereas,** the J&K Public Service Commission vide letter No. PSC/DR/AP/Geology/2017 dated. 31-03-2023 had recommended the name of Ms. Sumaira Nazir Zaz D/o Mr. Nazir Ahmad Zaz R/o Ho.No.66, Block-B, Badshah-Nagar, Natipora and Mr. Rasikh Barkat S/o Mr. Barkat Ahmad Rather R/o G-243, Shurat under OM Category, among others, for appointment as Assistant Professor (Geology) in the pay scale of Rs.15600-39100 with AGP of Rs.6000/-; in the Higher Education Department; and

**Whereas,** after getting the satisfactory reports from the CID, the Higher Education Department vide Government Order No. 425-JK. (HE) of 2024 dated 16-08- 2024 issued appointment order in favour of Ms. Sumaira Nazir Zaz D/o Mr. Nazir Ahmad Zaz R/o Ho.No.66, Block-B, Badshah-Nagar, Natipora and Mr. Rasikh Barkat S/o Mr. Barkat Ahmad Rather R/o G-243, Shurat under (OM Category) with the directions to report to the Nodal Principal, Government College of Education, Srinagar within a period of 21 days from the date of issuance of the order, failing which the appointment shall be deemed to have cancelled without any further notice; and

**Whereas,** the Nodal Principal, Kashmir vide her office letter dated 18-12-2024 intimated that Ms. Sumaira Nazir Zaz D/o Mr. Nazir Ahmad Zaz R/o Ho.No.66, Block-B, Badshah-Nagar, Natipora and Mr. Rasikh Barkat S/o Mr. Barkat Ahmad Rather R/o G-243, Shurat have not joined in pursuance to the Government Order No. 425-JK (HE) of 2024 dated 16-08-2024;and

**Whereas,** the Higher Education Department issued a Notice to Ms. Sumaira Nazir Zaz and Mr. Rasikh Barkat dated 04-03-2025, with the directions to immediately join the concerned College within a period of 07 days from the date of its publication, but they have not responded to that Notice and failed to join as reported by the Nodal Principal, Kashmir vide her office communication dated 18-03-2025; and

**Whereas,** as per Circular No.08-JK (GAD) of 2019 dated 04-12-2019 issued under Endorsement No. GAD(Ser)Genl/Circ/06/01 dated 04-12-2019, it has been provided that the candidates who fail to join within a period of 21 days from the date of



issuance of the appointment order shall forego their right to appointment which shall be deemed to have been cancelled ab-initio without any further notice.

**Now, therefore, consequent upon the above,** the appointment of Ms. Sumaira Nazir Zaz D/o Mr. Nazir Ahmad Zaz R/o Ho.No.66, Block-B, Badshah-Nagar, Natipora and Mr. Rasikh Barkat S/o Mr. Barkat Ahmad Rather R/o G-243, Shurat made as Assistant Professor (Geology) under OM Category vide Government Order No.425-JK (HE) of 2024 dated 16-08-2024 issued by the Higher Education Department, so far as the same pertains to them only shall and shall be deemed to have been cancelled ab-initio.


