Subject: Issuance of "Censure" to Prof Tariq Ashai, Principal.

Government Order No: 09 -JK (HE) of 2023 Dated: 0 -01-2023

Whereas; Dean Academic Affairs, Cluster University Srinagar Vide letter No.CUS/VC/10-11/2022 Dated:04.11.2022 forwarded a complaint against Mr. Tariq Ashai, I/C Principal GDC Pattan.

Whereas; Higher Education Department vide Government Order No. 248-JK(HE) of 2022 dated 09-11-2022 appointed Mr. Sushil Kumar Khajuria, JKAS, Additional Secretary to the Government, Higher Education Department as an enquiry officer.

Whereas; vide Government Order No. 249-JK(HE) of 2022 dated 09-11-2022, Mr Tariq Ashai, I/C Principal GDC Pattan was attached in the Administrative Department till outcome of the enquiry.

Whereas; an enquiry officer has submitted enquiry report with the recommendation that Mr. Tariq Ashai has not maintained the sanctity of chair, as such a strict warning under Rule 30 of the Civil Services (Classification, Control and Appeal) Rules, 1956 i.e "Censure" may be issued with the advise to restrain from such acts even in adverse situation and shall remain careful in future. However, the victim viz. Dr. Khurshid Ahmed Controller of Examination may also be admonished to refrain from such acts which may lead to provocation.

Therefore, in view of the above, Mr. Tariq Ashai, Principal is hereby issued strict warning under Rule 30 (i) "Censure" of the Civil Services (Classification, Control and Appeal) Rules, 1956.
