Subject:- Appointment of Jr. Laboratory Assistant (Divisional Cadre Kashmir)
in Higher Education Department

As recommended by J&K, Services Selection Board, sanction is hereby accorded to the appointment of Mr. Balvinder Kumar S/o Khareti Lal Bhagat R/o Rang Pur Sadhra R.S Pura Jammu as Junior Laboratory Assistant (Divisional Cadre Kashmir) on temporary basis in the pay scale of Rs. 5200-20200+1900 GP in Higher Education Department. He is posted in Amar Singh College, Srinagar against an available post.

Appointee shall report to Principal Amar Singh College, Srinagar, within a period of 21 days from the date of issuance of this order. He shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

1. Academic/Technical Qualification Certificates.
2. Date of Birth Certificate.
3. Health Certificate issued by the Competent Authority.
4. Permanent Resident certificate.
5. All other relevant certificates.
6. Certificate from General Manger, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any scheme.

In case appointee fails to join within the stipulated period of 21 days, his appointment shall be cancelled without any further notice.

The appointment of the candidate shall however, be on probation for a period of five (5) years. During the period he shall be entitled to salary in terms of J&K Special Recruitment Rules, 2015 notified vide SRO 202 of 2015 dated: 30-06-2015 and shall be entitled for fixation of pay in the time scale of pay applicable to the post after completion of 05 years of satisfactory.

The appointment shall be subject to the following conditions:-

- a) The appointee shall give an undertaking duly attested by a Judicial Magistrate to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police CID,JK to whom a reference shall be made by the concerned Principal, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on his appointment and also criminal proceeding shall be initiated against him.
- b) The verification of qualification/reserved category certificate (wherever applicable) from the concerned quarter/issuing received.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) and (b) above is received.

Further, if on verification, at any stage, the certificates produced by the appointee prove fake or forged, the appointment shall be treated as cancelled ab-initio.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending in any court of law.
