Subject:- OA.No.1658/2023 titled Abid Aziz v/s UT of J&K & Ors.

**Government Order No. 83-JK (HE) of 2024  
Dated: 21.02.2024**

Whereas, applications were invited through the online portal for effecting transfers of Assistant Professors, Associate Professors, Physical Training Instructors and Librarians. Detailed instructions were issued for applying through online Portal;

Whereas, the applicant Mr. Abid Aziz, Assistant Professor in Economics applied through online portal and he was transferred from Government Degree College, Banihal (Zone C) to Government Degree College Sarh Bagga Mahore (Zone C) vide Government Order No. 358-JK(HE) of 2023 dated 04.12.2023;

Whereas, the applicant being aggrieved of the Government Order No. 358-JK(HE) of 2023 dated 04.12.2023, filed OA.No.1658/2023 titled Mr. Abid Aziz v/s UT of J&K & Ors before the jurisdictional Tribunal of Hon'ble Central Administrative Tribunal at Jammu praying for following reliefs:-

- i. Quash the impugned Government Order No.358- JK(HE) of 2023dated 04.12.2023 to the extent Serial No. 11, whereby the applicant herein has been transferred from his present place of posting i.e Government Degree College Banihal (Zone C) to Government Degree College Mahore (Zone D).
- ii. Any other relief which the Hon'ble Tribunal may deem fit and appropriate in the facts and circumstances of the case.

Whereas, the Hon'ble Central Administrative Tribunal after hearing the applicant disposed the OA by passing order dated 20.12.2023, the operative part of which is reproduced as under:

"..... Accordingly, the Original Application is disposed of with a direction to respondents to treat this O.A. as representation of the applicant and decide the same by passing a reasoned and speaking order.

Respondents are further directed to, communicate the order so passed to the applicant. Before passing any order, the applicant shall also be afforded an opportunity of hearing. The whole exercise

shall be undertaken within a period of three weeks from the date of receipt of a certified copy of this order.

Until a final decision is taken on the representation of the applicant, status quo as on today shall be maintained, qua the applicant.

With these directions, O.A. No. 1658 of 2023 is disposed of.

However, there shall be no orders so as to costs."

Whereas, in compliance to the directions of the Hon'ble Central Administrative Tribunal, dated 20.12.2023, the applicant was requested to appear in the Administrative Department for hearing on 02.02.2024. The applicant appeared virtually on the scheduled date and time and was heard;

Whereas, the applicant has stated that he has been transferred from GDC Banihal to GDC, Sarh Bagga Mahore inspite of the fact that the applicant is a resident of Anantnag and has been serving in Banihal, which is already in a different division.

Now, therefore, in the light of the above stated facts and circumstances, the claim of the applicant has been considered and he has been retained in the GDC, Banihal.
