As recommended by the J&K, Service Selection Board Jammu, sanction is hereby accorded to temporary appointment of Shri Nazir Ahmad Bhat S/ O Mohammad Ramzan Bhat R/O Reshipora Shopian (RBA category) (Divisional Cadre, Kashmir) as Electrician in the pay scale of Rs. 5200-20200+GP Rs. 1900/- in the Higher Education Department (Divisional Cadre, Kashmir).

The appointee is adjusted at Government Degree College (Boys) Anantnag against an available vacancy. The appointment of the candidate is also subject to the following conditions:-

Appointee shall report to concerned College within a period of 21 days from the date of issuance of this order and he shall be allowed to join only on production of following certificates/documents in original which shall be verified subsequently from the concerned quarter:-

- Academic/Technical Qualification Certificates.
- 2. Date of Birth Certificate.
- Health Certificate issued by the Competent Authority.
- 4. Permanent Resident Certificate.
- Valid Category Certificate.
- 6. Certificate from General Manager, DIC concerned and Deputy Director, Employment concerned to the effect that no loan has been taken by the candidate under any Scheme.

In case appointee fails to join within the stipulated period of 21 days, their appointment shall be cancelled without any further notice.

The appointment shall be subject to the following conditions.

a) The appointee shall give an undertaking duly attested by a Judicial Magistrate, to the effect that in case adverse report about his character and antecedents is received from the Inspector General of Police CID, J&K to whom a reference shall be made by the department, his appointment shall be deemed to be cancelled ab-initio and he shall have no claim on their appointment.



b) The verification of qualification/ reserved category certificate (wherever applicable) from the concerned quarters/issuing received.

Salary of the appointee shall not be drawn and disbursed unless a satisfactory report in respect of (a) & (b) above is received.

Further, if on verification, at any time, the certificates produced by the appointee prove fake or forged, the appointment of the candidate shall be treated as cancelled ab-initio and criminal proceeding shall be initiated against him.

The appointment of above candidate shall, however, be subject to outcome of writ petition, if any pending in any court of law.

Candidate shall be on probation for a period of two years from the date of joining into Government service and seniority of the appointee shall be maintained as per merit furnished by the Service Selection Board.
