- e. Health and Medical Certificate.
- f. Any other certificate as required under law.

The salary of the appointee shall be drawn and disbursed after the receipt of the satisfactory report in respect of genuineness of Qualification/Date of Birth/Relevant Category Certificate and subject to production of an affidavit (as per annexure A) to this order.
