The release of funds is subject to following conditions:

1. That due e-tendering procedure shall be followed for execution of these works and AA/TS shall be in place and procurement shall be made through e-tendering or GeM portal.
2. The Registrars/ Principals being the major Heads of Departments shall accord AA to the works which are within their competence as per the Book of Financial Powers after observing all Codal/ procedural formalities.
3. All codal formalities shall be observed prior to incurring of expenditure.
4. The funds shall be utilized for execution of the scheme strictly as per the GOI's prescribed guidelines.
5. The funds shall not be parked unnecessarily and shall not be available for re-appropriation at any level.
6. All necessary clearances/ approvals shall be sought from competent authorities before execution of approved works.
7. Director Finance, HED shall ensure transaction of funds through PFMS portal as per standing instructions of MHRD, Gol and shall vouchsafe the availability of funds.
8. **Being last installment of RUSA 1.0 under the component "Infrastructure Grants to Colleges", Mission Director, RUSA, J&K shall release the funds only after obtaining actual requirement from concerned institutions.**
9. Mission Director, RUSA, J&K shall monitor utilization of funds as per the RUSA guidelines and as per PAB approval.
10. The utilization certificate of funds shall be submitted immediately after incurring of expenditure.


