Formulation of policy regarding permission for pursuing part-time research work by the College Lecturers.

Government Order No.128-HE of 2001 Dated: 26 - 04 - 2001 ###

Sanction is hereby accorded to the formulation of policy regarding permission for pursuing part-time research work by the College Lecturers. The following will be the terms and conditions for pursuing these courses:-

- 1. No College teacher shall engage in part-time research without the permission of the Administrative Department.
- 2. A College teacher shall be allowed permission for part-time research only after completion of three years of regular service and after clearance of probationery period.
- 3. Senior teachers shall be given preference to junior teachers in each subject for engaging in part-time research.
- 4. Only one teacher (or two for bigger colleges) in each Science Department of a College shall be allowed to register for part-time research in a year.
- 5. The teachers who are allowed to register for part-time research shall carry on research work outside the working hours of Colleges and holidays as well as during vacations.
- 6. The applications for permission to allow part-time research shall be forwarded by the Principals of the respective Colleges to the Administrative Department with a certificate to the effect that the teaching work in the relevant subject will not suffer in case the teacher registers for part-time research.
- 7. Part-time research in Science shall be allowed only in favour of teachers posted in the Colleges of Jammu/Srinagar cities, unless the Supervisors of such research certify that they can carry on experimental work/field studies at their places of posting outside these two cities.
- 8. The teachers who are allowed to register for part-time research shall have to submit an undertaking to the effect that they shall serve in the Department at least 5 years after completing the Ph.D programmes; and
- 9. Teachers who register themselves for part-time research, shall not normally be eligible for a fellowship of UGC, under Faculty Improvement Programme. However, they can be recommended for this fellowship for a maximum period of one year for concluding their research programme on the basis of the report of the research-supervisor. Study leave shall be allowed as per requirements of the research fellows in terms of the statutes of Kashmir and Jammu Universities, SKUAST and other research organizations of the State.

10. Permission for registering as part-time research scholars in Universities outside the State shall be considered on case to case basis.

Violation of any other above conditions shall render the concerned render the concerned research scholar liable to action under rules.
