Whereas, J&K Service Selection Board vide letter No.SSB/Sel/Secy/2017/1649-55 dated 03-02-2017-2016 and No.SSB/Sel/Secy/2017/2345-56 dated 22-02-2017, recommended among others for appointment as Junior Laboratory Assistant, Divisional Cadre Jammu in Higher Education Department;

Whereas, J&K Higher Education Department vide Government Order No.451-HE of 2017 dated 02-08-2017 accepted the recommendation of J&K Service Selection Board and Mr. Rohit Sharma S/o. Chander Prakash Sharma, R/o. Bhour Camp W. No.02, Jammu stands appointed as Junior Laboratory Assistant on regular temporary basis in pay scale of Rs.5200-20200+GP 1900 with the direction to join in Govt. Degree College, Sara Bagga Mahore within a period of 21 days from date of issuance of appointment order failing which your appointment shall be deemed to have been cancelled without any notice;

Whereas, Mr. Rohit Sharma represented to this Department for extension of joining time for some more time as his father is suffering from spinal cord injuries for last two months;

Whereas, the appointee was advised vide letter No.HE-Coll/NGJ/Apptt/JLA/ 329/2017 dated 21-092017 to join the College where he has been posted within a period of 07 days, otherwise his appointment shall be cancelled without any further notice;

Whereas, the appointee was requested by this Department for extension of his joining time upto 03 months;

Whereas, the said candidate has not joined the Department within a period of 21 days from the date of issuance of order, later on department advised Mr. Rohit Sharma to join the college within a period of 07 days, otherwise his appointment shall be cancelled without any further notice vide letter dated 21-09-2017, but he again failed to join the College within the prescribed period of time given to him by this Department;

Whereas, the Higher Education Department issued notice through print media to Mr. Rohit Sharma directed him to report to Govt. Degree College, Sara Bagga Mahore within a period of 15 days from the date of publication of this notice, failing which his appointment shall be deemed to have been cancelled automatically without any further notice

Whereas, the appointee have failed to join his service, even after sufficient opportunities were given by Higher Education Department;

Now, therefore, having failed to join in the Higher Education Department, the appointment of Mr. Rohit Sharma, S/o. Chander Prakash Sharma, R/o. Bhour Camp W. No.02, Jammu as Junior Laboratory Assistant vide Govt. Order No.451-HE of 2017 dated 02-08-2017 under endorsement No. HE-Coll/NGJ/Apptt/JLA/329/2017, is hereby cancelled in-abitio.
