Subject: Cancellation of appointment of Sh. Iftikhar Ahmad Shah as Assistant Professor (Kashmiri) in Higher Education Department.

Government Order No. 289 - HE of 2017
Dated: - 23 -05- 2017

Whereas, J&K Public Service Commission vide letter No.PSC/DR/ Kashmiri/Asstt Prof./2014 dated 09-03-2016 recommended Sh. Iftikhar Ahmad Shah S/O Ghulam Mohammad Shah R/O Kralwari Tehsil Chadoora Districat Budgam for appointment as Assistant Professor in Kashmiri in Higher Education Department; and


Whereas, J&K Higher Education Department vide Government Order No. 194-HE of 2016 dated 19-05-2016 accepted recommendations of J&K Public Service Commission and appointed Sh. Iftikhar Ahmad Shah as Assistant Professor in Kashmiri, on regular temporary basis, in pay scale of Rs. 15600-39100 with AGP of Rs. 6000; Subsequently, he was posted as Assistant Professor (Kashmiri) in Government Degree College, Beerwah and was directed to report to concerned Principal within a period of 21 days from the date of issuance of appointment order, otherwise his appointment will be deemed to have been cancelled; and

Whereas, Principal, Government Degree College, Beerwah informed this Department vide Communication No. GDCB/16/645 dated 26-11-2016 that said appointee did not report before him within prescribed time and as such the post is lying vacant, and

Whereas, the department vide Notice No: Apptt/AP/101/Kashmiri dated: 31 -01-2017, directed Sh. Iftikhar Ahmad Shah to report to Principal Government Degree College, Beerwah within a period of fifteen days from the date of receipt of notice or its publication in local daily, whichever happens earlier, failing which his appointment shall be deemed to have been cancelled; and

Whereas, Principal Government Degree College, Beerwah again reported that the said Assistant Professor has not joined his services even after the lapse of stipulated time granted by this department, instead approached his office with a representation, stating that he is working in J&K Academic and Art Culture and Languages, Srinagar on a pensionable Gazetted post and requires clarification from Finance Department for continuation of his pensionary benefits under old pension scheme; and

Whereas, Sh. Iftikhar Ahmad Shah was supposed to join his services in Higher Education Department & later seek any clarification regarding personal benefits under old pension scheme. Instead he resorted to delaying tactics for more than one year as a result of which study of students has been adversely affected due to vacancy created in GDC, Beerwah; and



Whereas, the Department served a Show Cause Notice to the said Assistant Professor vide No.HE/Apptt/AP/101/Kashmir dated 23-03-2017 wherein he was directed to submit written objections within seven days against departmental action for cancellation of his appointment. Despite lapse of more than one month nothing was received from his side, thereby making it clear that the Assistant Professor has nothing to say in his defense.

Now, therefore, in view of above, the appointment of Sh. Iftikhar Ahmad Shah S/o Ghulam Mohammad Shah R/O Kralwari Tehsil Chadoora Districat Budgam (RBA Category) as Assistant Professor (Kashmiri) in Higher Education Department is hereby cancelled.
