Subject: Termination of appointment of Mr. Imran Khan, Assistant Professor (Bio-chemistry) Higher Education Department.

Government Order No. 221 HE of 2017.
Dated: 17 -04- 2017.

Whereas, J&K Public Service Commission vide letter No.PSC/DR/ Asstt Prof./Bio-chemistry/13-14 dated 15-12-2016 recommended Mr. Imran Khan S/o Gh. Nabi Khan R/o Mangnipora, Muradpora, Bandipora for appointment as Assistant Professor (Bio-chemistry), under open merit category in Higher Education Department; and

Whereas, this department vide Government Order No. 393-HE of 2016 dated 30-12-2016, accepted recommendations of J&K Public Service Commission and appointed Mr. Imran Khan as Assistant Professor in Bio-chemistry on probation, in pay scale of Rs. 15600-39100 with AGP of Rs. 6000/- and with the direction to report to Nodal Principal, A.S. College, Srinagar within a period of 21 days from date of issuance of appointment order, failing which his appointment shall be deemed to have been cancelled without any notice; and

Whereas, Nodal Principal, A.S. College, Srinagar reported that Mr. Imran Khan, Assistant Professor (Bio-chemistry) did not join his services within stipulated time period and as such the post is lying vacant ; and

Whereas, in the mean time this Department received a representation from Mr. Imran Khan, whereunder it was stated that he is working as Post Doctoral Research Associate in University of Illinois at Chicago, USA and requested to extend his joining time for about one year, enabling him to complete his research work; and

Whereas, the representation of Mr. Imran Khan was examined and it was observed that grant of extension in joining time in favour of appointed candidates is not permissible under rules; and therefore Vide Notice No: HE/Apptt/AP/Bio-chemistry/2016 Dated 10-03-2017, Mr. Imran Khan, Assistant Professor (Bio-chemistry) was directed to report Nodal Principal, A.S. College, Srinagar within a period of Fifteen days from date of receipt of notice or its publication in local daily whichever is earlier, failing which his appointment shall be deemed to have been cancelled without any further notice. For wider communication, the notice was also uploaded on official website of Higher Education Department; and

Whereas, Nodal Principal, A.S. College, Srinagar again reported that Mr. Imran Khan, Assistant Professor (Bio-chemistry) has failed to join his services despite final opportunity granted by Administrative Department; and

Whereas, J&K, Public Service Commission has completed the selection process of Assistant Professors after several years of delay due to litigation. During this period, the teaching learning atmosphere in Govt. Degree Colleges has been adversely affected. Hence such negligent attitude of Assistant Professors towards his services and non responsiveness towards directions of Administrative Department is un-desirable;

Now, therefore, in view of above, appointment of Mr. Imran Khan S/o Gh. Nabi Khan R/o Mangnipora, Muradpora, Bandipora as Assistant Professor (Bio-chemistry) in Higher Education Department is hereby cancelled.
